*Some commercial self-funded groups are extending the waiver of member cost share. In addition, some Medicare Advantage groups have a different end date for the waiver of member cost share. Providers are encouraged to submit claims to Blue Cross and BCN and wait for the voucher before charging member cost share, if applicable.

**Effective Jan. 1, 2021, Medicare Plus Blue and BCN Advantage individual plan members have no member cost share for PCP and behavioral health telehealth visits, as well as in-person PCP visits. These are part of 2021 plan coverage (no longer temporary benefits). However, cost share applies to in-person behavioral health services. Check benefits for group members.
